Photography/Video Consent Form

As a school, we sometimes take photographs and videos of pupils. We use these to support teaching and learning and to celebrate events and achievements that have taken place in school. All images and videos taken are held in line with the school's retention schedule.

How do we use photographs or videos taken of your child?

Group and individual photographs are used for internal displays, teaching resources, school documents and parent handbooks. The child(s) first and last name and year group, where required, may be used on an internal display board in the classroom or around school.

Group and individual photographs which are going to be used in the school newsletter, school publications or published online, will NOT name your child, unless we specifically request your consent.

We allow parents and other family members to take photographs during special school events such as Sport's Day, on the understanding that these are for personal use only. We request that parents/carers do not post any images that include other children on social media.

The school will always use your child's image in line with UK Data Protection Laws. You have a number of rights in relation to how we use your child's image and you can withdraw your consent at any time.
